

## **Securities Transfer Instructions for Donors**

(Feel free to make copies of this packet as needed)

Your Missouri United Methodist Foundation can assist you in making your gift to any United Methodist church or related charitable organization. We receive the securities, sell them, and then send the net proceeds to the church or charity as you have directed.

## Transferring Securities Held by a Broker or Bank

- 1. Most shares of stock are held in electronic form by your broker or bank. These shares can be easily transferred directly to the Foundation's account. Use the form on the reverse side of this page to send instructions to your broker.
- 2. Please send a copy of the broker instructions by mail or fax to the Foundation:

3. When the transfer is completed, you will receive a gift receipt letter confirming the description of the shares and date the shares were received by the Foundation. We include a gift valuation as of the date of receipt. Save this material for your tax reporting purposes.
